#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Tennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below in the 1st column is needed for a public purpose and will be acquired under the provisions of that Act. It describes in the 2nd column from which land that the servitude will be acquired.

Acquisition of servitude over the land for the laying of pipe lines of Balangoda Water Supply Scheme Augmentation Project.

**Declaration under Section 5**

I, Janaka Bandara Tennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.
