Provincial Councils Notifications

SOUTHERN PROVINCE PROVINCIAL COUNCIL

NOTIFICATION

I, Gustingnawadu Shan Wijayalal De Silva, the Chief Minister and the Minister of Finance, Planning, Law and Order, Transport, Water Supply and Drainage, Electricity, Engineering Services, Health, Indigenous Medicine and Local Government of the Southern Province, do hereby impose the following regulations relating to the travelling expenses of the mayors, deputy mayors and councillors of municipal councils, made by me under the powers vested in me in terms of Section 289 of the Municipal Councils Ordinance (Chapter 252) read with Section 2 of the Provincial Councils (Ancillary Provisions) Act, No. 12 of 1989. These regulations shall take effect from 01.01.2012.

Regulations

01. These Regulations may be cited as “Regulations on the Payment of Travelling Expenses of Mayors, Deputy Mayors and Councillors of the Municipal Councils.”
02. A Mayor, Deputy Mayor or a Councillor of a Municipal Council who uses his own vehicle on any official functions assigned to him by the Council, may be paid a fee per kilometer at the rate specified below as a reimbursement of expenses incurred in travelling.
 - (i) For a motor car/three wheeler — Rs. 10.00 per km
 - (ii) For a motor cycle — Rs. 4.00 per km
 - (iii) In the case of public transport the actual amount paid.
03. If the motor car/ three wheeler or the motor cycle used on official functions is not his own, it may be treated as own vehicle if the following documents relating to the motor car/three wheeler or motor cycle concerned, are produced.

- (i) Certified copy of the certificate of registration ;
 - (ii) Certified copy of the annual revenue license ;
 - (iii) Certified copy of the valid insurance certificate ;
 - (iv) An affidavit sworn by the owner of the vehicle authorising the use of motor car/three wheeler or the motor cycle concerned.
4. The sum total of the travelling expenses paid to a mayor, deputy mayor or councillor, shall be subject to a maximum of Rs. 3,000.00 per month.
 5. The functions for which travelling expenses are paid as above, shall be those assigned by a decision of the council/mayor. Further they shall pertain to the administrative or development activities of the council.
 6. Where the travelling expenses are payable to the mayor, the functions for which such expenses are paid shall have been assigned to him under the provisions of the Municipal Councils Ordinance or by a decision of the council.
 7. The Mayor, Deputy Mayor or Councillor of a Municipal Council when applying for travelling expenses, shall apply in accordance with the form Gen. 161 referred to in the Financial Regulations of the Government.
 8. Provision shall have been provided in the annual budget to meet the travelling expenses of the Mayor, Deputy Mayor or Councillors of a Municipal Council.

NOTIFICATION

I, Gustingnawadu Shan Wijayalal De Silva, the Chief Minister and the Minister of Finance, Planning, Law and Order, Transport, Water Supply and Drainage, Electricity, Engineering Services, Health, Indigenous Medicine and Local Government of the Southern Province, do hereby impose the following regulations relating to the travelling expenses of the chairman, vice chairman and members of Urban Councils, made by me under the powers vested in me in terms of Section 193(2)(h) of the Urban Councils Ordinance (Chapter 255) read with Section 2 of the Provincial Councils (Ancillary Provisions) Act, No. 12 of 1989. These regulations shall take effect from 01.01.2012.

Regulations

01. These Regulations may be cited as “Regulations on the Payment of Travelling Expenses of Chairman, Vice Chairman and Members of the Urban Councils.”.
2. A Chairman, Vice Chairman or a Member of an Urban Council who uses his own vehicle on any official functions assigned to him by the Council, may be paid a fee per kilometer at the rate specified below as a reimbursement of expenses incurred in travelling.

- (i) For a motor car/three wheler — Rs. 10.00 per km
 - (ii) For a motor cycle — Rs. 4.00 per km
 - (iii) In the case of public transport the actual amount paid.
3. If the motor car/ three wheeler or the motor cycle used on official functions is not his own, it may be treated as own vehicle if the following documents relating to the motor car/three wheeler or motor cycle concerned, are produced.
- (i) Certified copy of the certificate of registrations ;
 - (ii) Certified copy of the annual revenue license ;
 - (iii) Certified copy of the valid insurance certificates ;
 - (iv) An affidavit sworn by the owner of the vehicle authorising the use of motor car/three wheeler or the motor cycle concerned.
4. The sum total of the travelling expenses paid to a Chairman, Vice Chairman or Member, shall be subject to a maximum of Rs. 3,000.00 per month.
5. The functions for which travelling expenses are paid as above, shall be those assigned by a decision of the Council/Chairman. Further they shall pertain to the administrative or development activities of the council.
6. Where the travelling expenses are payable to the Chairman, the functions for which such expenses are paid shall have been assigned to him under the provisions of the Urban Councils Ordinance or by a decision of the Council.
7. The Chairman, Vice Chairman or Members of an Urban Council when applying for travelling expenses, shall apply in accordance with the form Gen. 161 referred to in the Financial Regulations of the Government.
8. Provision shall have been provided in the annual budget to meet the travelling expenses of the Chairman, Vice Chairman and Members of an Urban Council.

3. If the motor car/ three wheeler or the motor cycle used on official functions is not his own, it may be treated as own vehicle if the following documents relating to the motor car/three wheeler or motor cycle concerned, are produced.
 - (i) Certified copy of the certificate of registrations ;
 - (ii) Certified copy of the annual revenue licence ;
 - (iii) Certified copy of the valid insurance certificate ;

7. The Chairman, Vice Chairman or Member of a Pradeshiya Sabha when applying for travelling expenses, shall apply in accordance with the form Gen. 161 referred to in the Financial Regulations of the Government.
8. Provision shall have been provided in the annual budget to meet the travelling expenses of the Chairman, Vice Chairman or Members of a Pradeshiya Sabha.

AMENDMENT

I, Shan Wijayalal De Silva, the Chief Minister and the Minister in charge of the subject of Local Government of the Southern Province, do hereby amend as hereunder the Section 3(1) of the regulations relating to the allowances payable to Chairman, Vice Chairman and Members of Pradeshiya Sabhas, made by me under the powers vested in me in terms of Section 184 of Pradeshiya Sabha Act, No. 15 of 1987 read with Section 2 of the Provincial Councils (Ancillary Provisions) Act, No. 12 of 1989 and published under Provincial Council Notices, in Part IV(A) of the *Gazette Extraordinary* No. 1413/15 dated 05th October 2005 of the Democratic Socialist Republic of Sri Lanka, by substituting the words “Pradeshiya Sabha” in place of “Municipal Councils” therein.

3(I) A Chairman, Vice Chairman or Member of a Pradeshiya Sabha will not be entitled to the said allowances on the following instances.
