FILLING OF A VACANCY IN THE OFFICE OF CHAIRMAN OF THE NOCHCHIYAGAMA PRADESHIYA SABHA UNDER SECTION 65A(1) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of Chairman in Nochchiyagama Pradeshiya Sabha has fallen vacant by reason of being elected as a member of the North Central Province Provincial Council ;

And whereas the Secretary of the United People's Freedom Alliance, the recognized political party to which the K. P. S. **FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE GALENBINDUNUWEWA
PRADESHIYA SABHA UNDER SECTION 65A(2) OF THE LOCAL AUTHORITIES ELECTIONS
