Resolution :-

32. Namely Thalpotha town described in the following schedule in Lankapura Pradeshiya Sabha area in terms of Section 134(1) of Pradeshiya Sabha Act No.15 of 1987.

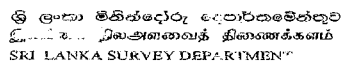
North .— Bounded to the area starting from 317 Junction of Polonnaruwa Singhapura road towards “Somasiri Stores” (Covering 100 meters towards west from the center axis) and headed to the by road to Hingurakgoda (Covering 100 meters towards north) and up to the running across 141 and 151 through Weliela road (Covering 100 meters towards west)

East .— Bounded to the area running through Polonnaruwa Singhapura road passing 316 junction and up to 317 junction running close to Pradeshiya Sabha name board (Covering 100 meters from the center axis)

South .— Bounded to the area starting from Kaluwaragashandiya and running close to weekly fair up to “Peris Boutique” and from that point up to 316 junction through Polonnaruwa Singhapura road.

West. — From Kaluwaragashandiya to public well through Pradeshiya Sabha road (Covering 100 meters towards west from center axis) and up to starting point of the lane running across 141 and 151 lands (As covering 100 meters towards west.)

Hon. — Pradeshiya Sabha Councillor Mr. W. M. S. P. B. Wijekoon suggested the area referred above and marked in the survey plan No. : Po/LP/2009/146 to be a developed area on 30.11.2010. The resolution No. 32 made by Hon. Pradeshiya Sabha Councillor Mr. W. M. S. P. B. Wijekoon was seconded by Hon. Pradeshiya Sabha Councillor K. Wijethunga. Consequently, Hon. Chairman Manju Sri Aluthwatte presented the same to the council and such resolution was unanimously passed.



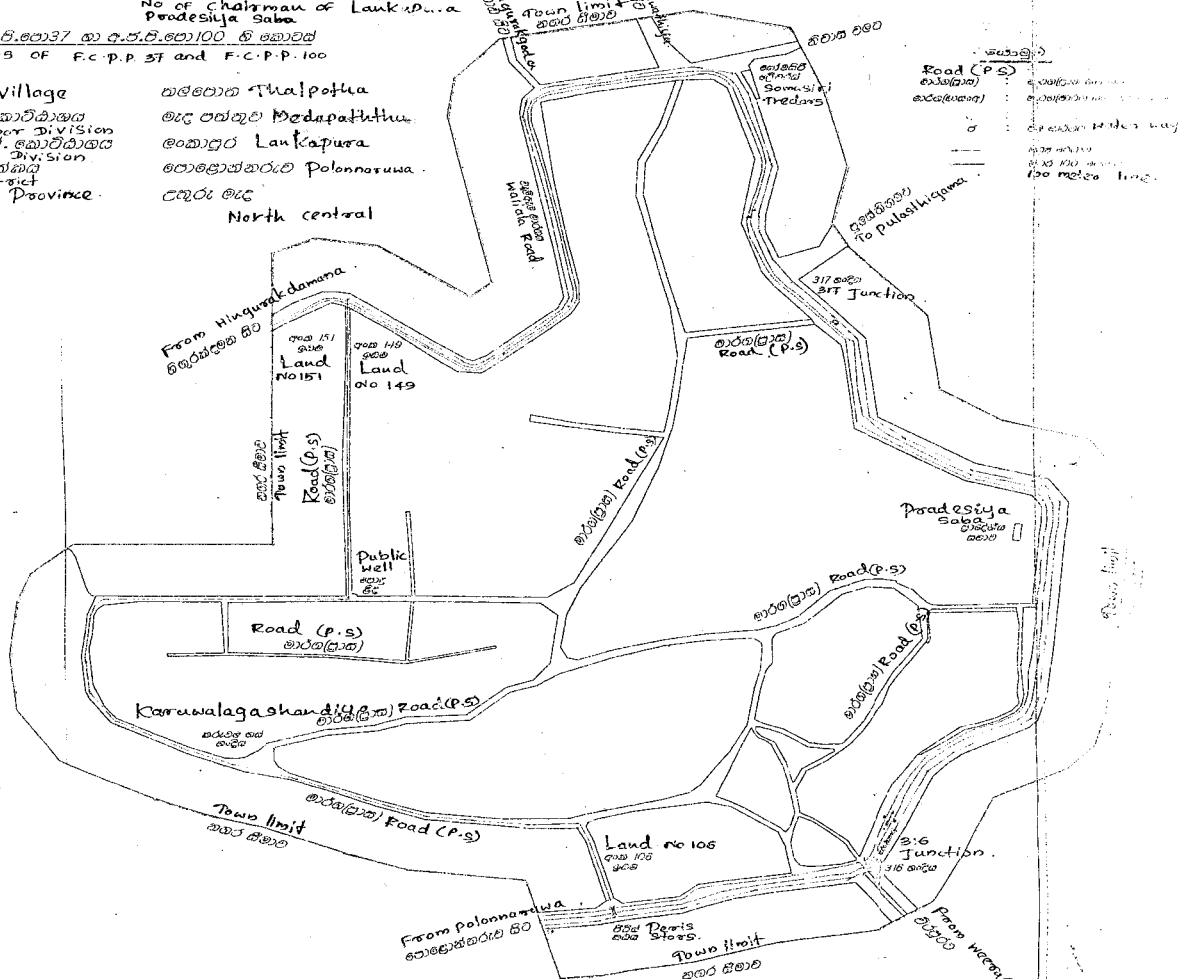
