FILLING OF A VACANCY IN THE OFFICE OF CHAIRMAN OF THE MAWANELLA PRADESHIYA SABHA UNDER SECTION 65A(1) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)
