#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Allotments of land described in below names and extents in total extent of about 6807.0 Sq.m., depicted in Advance Tracing No. 158 of 24.02.1982 situated in the Village of Chavakachcheri in the Assistant Government Agent's Division of Thenmaradchi in Jaffna District of the Northern Province and bounded as follows:

**01. Lot No. 01 – Kadatkaraikiraivayalum, Thalaiyadium – Extent: About 841.8 Sq. m.**
