Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development, hereby declare under Sub-section (1) of section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Three (03) allotments of land called “Dangollahena” in total extent of about 0.0195 Hectare, shown in the Advance Tracing No. Maha/UDN/2009/284 and dated 11.12.2009, prepared by the Superintendent of Surveys Kandy District, situated in the village of Hiddaula and Hiyarapitiya in Meda Palatha Korale Minor Division in the Divisional Secretary’s Division of Udunuwara in Kandy District in Central Province and bounded as follows:

01. Lot “A” – Dangollahena – Extent: About 0.0025 Hectare.

03. Lot “C” – Dangollahena – Extent: About 0.0112 Hectare.

Maha 4070; South: Lot No. 6 1/2 of P. P. Maha 4070; West: Lot No. 6 1/2 of P. P. Maha 4070 and Lot No. 6 of P. P. Maha 5917.
