Grade II

Assistant Ice-cream/Fruit juice, Jam makers (by adding natural and artificial essences), Other workers engaged in the Manufacture of materials related to this trade, Repairers of cans, Carbon-dioxide gas controlmen, Assistant syrup makers, syrupers, Crowners, Clean Bottle examiners, Carbonator operators, Production counters, Filers (hand), Labelers (automatic), Bottle washer-off leaders, any other workers engaged in automatic machines in the production of aerated waters, ice-harvesters.

Grade III

Ice-cream/Fruit juice/jam can-fillers, Ice-cream/fruit juice/jam packers, Ice-packers, Bottle unpackers, Ice-loaders, Syrup-room labourers, Bottle washer loaders, Bottle sorters or cleaners Case fillers, Bottle-packers, Cleaners or sweepers, Bottle cleaners (hand), Case-carriers or stackers, Stores labourers, Labelers (hand) and vehicle loaders.

Class of Workers :-

Grade II :-

Workers employed in -receiving fibre into stores from Lorries or carts ; counting ballots and bundles ; weighing ballots and bundles ; sorting fibre ; stacking ballots and bundles ; breaking Stacks of ballots and bundles ; unwrapping ballots and bundles ; picking and teasing ; bundling loose fibre ; drying loose fibre ; removing ; ballots and bundles from one part of the stores to another ; trimming of cut bristle fibre hanks ; curling ; balloting or coiling of

twisted fibre ; cutting firewood for dyeing ; issuing oil for hanking, cutting bristle fibre ties ; sweeping of stores and drains ; carting coir dust and rubbish ; placing coir dust and rubbish in vehicles for removal ; sifting coir dust ; bagging coir dust and rubbish ; preparing tea ; distributing meals and tea ; receiving, counting, weighing, stacking, removing, cutting, preparing sundry materials used in packing and processing fibre ; removing ballots and bundles from stores, bleaching chambers or drying ground to bailing press ; passing fibre to press packers ; operating winches for moving press boxes ; sawing and splitting bamboos ; cutting hoop iron ; stretching coir ropes ; sweeping and cleaning press ; platform, pit and surroundings ; covering bales with jute hessian and stitching ; wrapping ballots with paper or jute hessian and marking all packages for shipment.

Intermediate Grade :-

workers employed in-throwing Fibre from ground level to press platform (if elevated) ; feeding fibre into teasing machines ; balloting fibre in balloting boxes ; twisting coir ropes from coir yarn ; the process of bleaching fibre with sulphur ; cutting bristle fibre hanks to specified length and the process of dyeing fibre.

Grade I:-

Workers employed in - packing bailing boxes with or without mechanical trammers ; controlling and operating the bailing press ; strapping, the bail with hoop iron or rope ; stacking ; unstacking carrying, moving loading and unloading bales, twisting curling fibre.

SCHEDULE

The decisions made by the Wages Board for the Tanning, Footwear and Leather Goods Manufacturing Trade and set out in the Schedule to the Notification published in *Gazette* No. 14921 of 28th August, 1970, as varied from time to time and last varied by the Notification in *Gazette Extraordinary* No. 1660/35 of 30th June, 2010, shall be further varied by the substitution of the following parts.

PART II

The minimum monthly rates of wages for time work applicable to the below mentioned classes of workers of the Tanning, Footwear & Leather goods Manufacturing Trade shall be the rates set-out in the table.

Classes of Workers

The Tanning of Leather :

Grade I:

Washing raw hides, boiling hides in line, debarring the skins, Fleshing the skins, Applying chemicals, Bleaching, Oiling, Shaving, Staking, Socking, Applying salt, Removing excessive oil.

Grade II:

Splitting, Spraying, filling of salt hides, Trimming, Selecting and grading of skins, Bafling, Operating Machine Slickering.

Grade III:

Application of flour and dryng, curing the hides, the work of cleaners and sweepers, any other Operation connected with or incidental to the work specified above.

The Manufacture and Repair of Footwear :

Grade I :

Compounding, upper making, fabric pasting (Mechanical Cutting soles) Cutting uppers, Edge trimming, mounting bottom Pressing, Heel building, Heel compressing, clicking of uppers Edge setting.

Grade II:

Loading, Pressing shoes, Binding uppers, Slotting, boring, Attaching buckles, stitching soles, Scouring, Skiving, Solution making, vamp setting, Eyeletting.

Grade III :

Mixing rubber cement, cutting straps, Reverting uppers, dipping in cement, Inserting uppers, Preparing uppers, cementing backseams, pasting soles, polishing, finishing, Issuing boxes, Labelling boxes, Stamping boxes the work of cleaners and sweepers, any other Operation connected with or incidental, to the work specified above.

The Manufacturing of Leather Goods :

Grade I :

Machine and hand clicking, Perforating and slit-cutting, Riverting, Hand pressing, Making Foot balls, Volley-balls and Net-balls, Making Travelling bags, document cases and purses (machine).

Grade II:

Fixing studs, Buckles and buttons, Embossing, Fixing locks, Fittings and handles sewing, Making Travelling bags document cases and purses (machine).

Grade III :

Marking, Applying cement and Paste Finishing, Inflating and stamping, any other Operation connected with or incidental to work specified above.

Learners or Apprentices.

The period of apprenticeship in relation to any learner or apprentice referred to above shall be deemed to consist of 156 working days.
