Declaration under Section 5

Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Boundaries to the Land of which the name and extent mentioned below and the total extent About 1.2136 Hectare, Lot No. "A - K" in the Advanced Tracing No. MR/MTR/2011/320 of 12th of November 2011, situated in the village of Nupewela in Kadawathsatara in the Matara Divisional Secretariat Division, Matara District, Southern Province.

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development, hereby give notice, under Sub section (1) of Section 5 of the Land Acquisition Act, that the government intends to acquire the right of servitude of the land is required for the public purpose which is describing below in column 1. The 2nd column describes that from what land it will be expected to acquire the right of servitude.

I

The acquire the right of servitude of the additional portion of land, where the transmission pipe line is layed down to reservoir in Asgiriya of Kandy and adjacent water supply scheme.

II

An allotment (01) of land called Pukra Estate *alias* Mapanawatura estate bearing an extent of about 0.0764 Hectare from the total extent, shown in the advanced tracing no.
