Memorandum of Understanding No. 01 of 2011

#### MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is made and entered into on this 3rd day of November 2011 between Bartleet  $\overline{1A - G \ 16055 \ -350 \ (2012/05)}$  Agencies (Private) Limited, a company duly registered in Sri Lanka and having its registered office at Level 1, Bartleet House, No. 65 Braybrooke Place, Colombo 2, hereinafter referred to as "the Employer" or "the Company" as appropriate, of the One Part and the Ceylon Mercantile, Industrial and General Workers's Union (CMU), a trade union duly registered in Sri Lanka and having its registered office at No. 3, 22nd Lane Colombo 3, hereinafter referred to as "the Union" of the Other Part.

Whereas the Union representing a Majority of the clerical, supervisory and allied grade staff of the Company has requested the Employer to consider Subscribing to the EFC/CMU Collective Agreement of 2011 and after considering all matters the Company has agreed to subscribe to the said Collective Agreement with effect from 1.9.2011 based on the following conditions, to which the parties to this agreement have concurred.

- 01. The union will give credit to the Company for the following salary revisions already granted :
  - (*a*) 20% annual wage revision granted in November 2009.
  - (b) 10% revision granted with effedt from 1.5.2011.

  - 02. In lieu of the wage revision of 20% granted at a above, the union agrees to forge the following payments applicable in terms of the Collective Agreement for the year 2011.
    - (i) Rs 1000/- to be consolidated into the salaries with effect from 01.01.2011.
    - (ii) The exgretia Payment referred to at clause 13 of the said Agreement.
  - 03. The Company will revise the salaries of employees covered and bound by the Agreement by 5% with effect from 1.9.2011.

In witness hereof parties have hereunto set their hands on this 3 rd day of November, Two Thousand and Eleven at the EFC headquarters in Rajagiriya.
