CUSTOMS NOTIFICATIONS

Order under Section 111 of the Customs Ordinance (Chapter 235)

BY virtue of the powers vested in me under Section 111 of the Customs Ordinance (Chapter 235) read with Article 44(2) of the Constitution of Democratic Socialist Republic of Sri Lanka, I, Mahinda Rajapaksa, President of Democratic Socialist Republic of Sri Lanka, do by this order declare and appoint Hambantota in the Southern Province to be a part of the Democratic Socialist Republic of Sri Lanka and its respective limits set out in Schedule “A”, I do further declare and appoint the places set out in the Schedule “B” to be legal quays within such limits for the loading and unloading of goods and declare the bounds and extent of such quays to be set out in the Schedule “B” within the Port of Hambantota.

SCHEDULE A- PORT LIMITS OF THE PORT OF HAMBANTOTA

The land area : A depicted in Plan No. S/M.I.S/381 dated 15.09.2008 made by S. R. Illeperumachchi, Licensed Surveyor bounded as follows :

- North by* : Mahaweli Authority Land (Line from L, 12 to L3), Road (Highways) and Arabokka Road ;
- East by* : Road (Highway), Part of Lewaya Egodaha (Line from L 15 to L 16), Arabokka Road, Road (PS), Ela, Alokapura Road, Target Road, Road (Highway), Part of Major's Garden (Line from L 17, L 18, L 19 to L 20) ;
- South by* : Ela, Road (PS), Alokapura Road, Target Road, High Water Line, Part of Mirijjawila Kela (Line from L 1 to L 11 via L 2, L 3, L 4, L 5, L 6, L 7, L 8, L 9, L 10) and 100 ft. Road (Highway) ;
- West by* : Part of Mirijjawila Kele (line from L 1 to L 11 via L 2, L 3, L 4, L 5, L 6, L 7, L 8, L 9, L 10) and 100 ft. Road (Highway), Mahaweli Authority Land (Line from L 12, L 13 and L 14).
