THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Seven (7) allotments of land called “Lonnarch Estate” in total extent of about 0.0909 Hectare, depicted in Advance Tracing No. NU/AMB/2010/38 of 30.06.2010 prepared by the Surveyor General situated in the Village of Lonnarch Estate, in the Divisional Secretary's Division of Ambagamuwa Korale in Nuwara Eliya District Central Province, and bounded as follows:

Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.
