STATUTORY DETERMINATION UNDER SECTION 19 OF THE LAND REFORM LAW, No. 1 OF 1972

WHEREAS a statutory declaration under Section 18 of the law has been made by Mr. Herath Mudiyaansela Meegahaele Appuhamy Herath of Hiyadala, Walpola, Minigamuwa, Galagedera, the Land Reform Commission by virtue of the powers vested in it under Section 19 of the Law, has made a statutory determination specifying the portion of agricultural land owned by the statutory lessee which he shall be allowed to retain. 1. An allotment of land marked Lot Nos. 644, 645, 646, 647 and 648 of the land called Ritigahatenne Asweddu hena Angei Kumbura, Tennewala Kumbura, Tannewela watta situated in the village Minigomuwa in the Minor Division of Udapalatha West Korale of the D. R. O.'s Division of Thumpane in the District of Kandy, Central Province, containing in extent 02 Acres, 1 Rood, 21 Perches, in the Final Village Plan No. 158, Supplement No. 02 made by the Surveyor-General together with the buildings and plantations thereon ; and
2. An undivided extent of 36 Acres, 3 Rood, 10 Perches, from and out of allotments of land marked Lot Nos. 157, 158 and 159 of the land called Merian Hill Estate situated in the village Sivurupitiya in the Minor Division of Ganatha Palatha of the D. R. O.'s Division of Thumpane in the District of Kandy, Central Province depicted in the Final Village Plan No. 168, Supplement No. 02 made by the Surveyor-General together with the buildings and plantations thereon.
