WESTERN PROVINCE PROVINCIAL COUNCIL

Statute of Preventing Public Health Nuisances, No. 03 of 2012

I, Angage Jagath Thilakasiri Perera, Hon. Minister of Health, Indigenous Medicine, Social Welfare & Women Affairs, Probation & Childcare and Council Affairs of Western Province Provincial Council do hereby impose following regulations which should be read along with Clause 21 of the Statute of Preventing Public Health Nuisances, No. 03 of 2012. These regulations shall come into effect from the date on which they are published on the *Gazette*.

RULES

- 1. The rules shall be cited as the Rules of Preventing Public Health Nuisances, No. 03 of 2012
- 2. The officers mentioned below who are nominated under Clause 26 of this Statute, shall be appointed as the authorized officers under this statute and they shall perform the duties and tasks subject to the supervision of the competent authority:
 - (a) Colombo, Gampaha, and Kalutara Regional Directors of Health Service of the Provincial Department of Health Services in the Western Province.
 - (b) Medical Officers of Health.
 - (c) Chief Medical Officers of Health, Additional Medical officers of Health and all other Medical Officers of Health serving in Municipal Councils.

- (d) Provincial Administrative Public Health Inspector.
- (e) District Administrative Public Health Inspectors.
- (f) Administrative Public Health Inspectors attached to offices of the Medical Officer of Health.
- (g) All field Public Health Inspectors serving under Department of Health Services in the Western Province.
- (h) Public Health Inspectors including Chief Public Health Inspectors attached to Local Government Institutions of the Western Province.
- 3. (1) A card should be introduced to every premises with the name of "Premises Card for Preventing Public Health Nuisances" in accordance with the format indicated in Schedule 1, to be used by the —competent authority or a representative of the competent authority who enters any premises as per Clause 15 of this Statute, to inspect any nuisance or nuisances mentioning his entering into the premises or the inspection he conducts.
 - (2) The said card shall be numbered in accordance with the number of the household given by the voters' register. If any household has not received such a number, the card shall be issued under a temporary number.
 - (3) The owner/occupant or caretaker of the premises shall be bound to ensure the safe custody of the card, to submit it when requested by the competent authority or a representative of the competent authority or any authorized officer and to respect the orders imposed by the card.
 - (4) The card shall not be misplaced, disfigured or destroyed and legal actions shall be taken against any owner/occupant or caretakers who do so.
- 4. The format of the paper containing the amount of the spot fine which is imposed by the authorized officer to the owner/ occupant or caretaker of the premises with his/her consent, in any case where the competent authority or authorized officer identifies that the orders of the Sub Clause (1) of Clause 5 of this statute are violated by keeping open tins, bottles, boxes, coconut shells, coconut husks, tire or any other material or vessel containing water with mosquito larvae, shall be in line with the format indicated in Schedule 2. The said format shall be perfected in three copies and the original and second copies shall be handed over to the person who is responsible for the offence. The third copy shall be kept under the custody of the authorized officer and the person who is responsible for the offence shall submit the second copy to the relevant Divisional Secretariat to pay the relevant fine
- 5. The notice to be issued to the owner/occupant or caretaker by the competent authority or authorized officer under Clause 4(1) of this Statute where an offence is revealed violating Clause 2 of this statute, shall be in line with the format indicated in Schedule 3. This format shall be completed in two copies and the first copy shall be handed over to the person who is responsible for the offence. The second copy shall be kept in the custody of the authorized officer.
- 6. The notice to be issued to the owner/occupant or caretaker by the competent authority or authorized officer under Clause 7 of this Statute where an offence is revealed violating Clause 5 of this statute, shall be in line with the format indicated in Schedule 4. This format shall be completed in two copies and the first copy shall be given to the person who is responsible for the offence. The second copy shall be kept in the custody of the authorized officer.
- 7. The spot fine mentioned in Sub Clause 6(1) of this Statute shall be Rs.2000/-. This amount can be revised on timely requirements.

- 8. (1) An amount which does not exceed 25% of the fine recovered from a person after making guilty by a court on an offence fallen under this statute can be awarded to the authorized officer who takes action to prove the offence committed by the person.
 - (2) An amount equivalent to 10% of the spot fine indicated in Sub Clause 1, Clause 6 of this Statute can be awarded to the officer who takes action to prove the offence committed by the person.
 - (3) The incentive from the spot fine shall be paid to the relevant officer by the Divisional Secretariat of the Divisional Secretary's Division where the relevant premises are situated.
- 9. (1) At the instances where an owner, occupant, caretaker of a certain premises or any authority of an institution indicated under Sub Clause 14 (1), to whom a written notice has been issued under Clauses 4 and 7 of this statute, neglects to follow the orders issued, an institution or company shall be entrusted to take actions or make orders to remove the nuisance after determining either by the competent authority or authorized officer that the public health nuisance at a certain premises shall be removed as per Sub Clause 1 of Section 9.
 - (2) The fee for the removal of public health nuisance to be paid to a person institution or company to whom the tasks to be performed at a certain premises are entrusted, shall be in accordance with the fee indicated in Schedule 5. Such amount of fees shall be revised from time to time by the competent authority in accordance with the market value.
 - (3) Any expense borne by a person institution or company for the removal of public health nuisance, to whom such tasks or steps are entrusted with regard to a certain premises shall be paid by the competent authority to such person institution or company after making proper estimate on the task or the step performed by the above mentioned parties.
 - (4) The amount borne by the competent authority for the removal of public health nuisance revealed at the premises shall be paid to the competent authority by the owner/occupant or caretaker of the premises. The specimen of the certificate containing the fee to be paid, which is prepared either by the competent authority or officer authorized by the competent authority shall be in accordance with the specimen attached in Schedule 6. The said specimen shall be prepared by the officer who is concerned to remove public health nuisance.
- 10. The specimen of the certificate prepared by the competent authority for the submission of particulars of the fine ordered under sub clause 9 (2) of the Statute to the courts under Sub Clause 9 (3) shall be in accordance with the specimen attached in Schedule 7

PUBLIC HEALTH NUISANCES

- 1. Discharging waste water into a public waterway.
- 2. Throwing garbage into drains or road or keeping garbage bins which are not well covered at public places.
- 3. Washing vehicles in such a manner that it makes a road, street, foot path untidy.
- 4. Causing animals to pass faeces on any entry road or public places.
- 5. Keeping any premises unclean, allowing waste water or toilet waste to overflow or leak and allowing stagnated water to stagnate further.
- 6. Keeping loathsome drains that emits bad smell.
- 7. Rearing cattle, goats and swine in such a manner that is a nuisance to public health.
- 8. Leaving a building parapet wall in a dilapidated state.
- 9. Keeping factory in such a manner that it is detrimental to public health
- 10. Keeping any article, material or liquid in such a manner that it is detrimental to health

- Transmitting sound through radio or other media in such a manner that it is hindrance to the public.
- 12. Placing any item/s or carrying out unauthorized construction in such a manner that it obstructs the main road or
- 13. Keeping tins, bottles, coconut shells, coconut husks, tyre, rain gutters, water tanks, artificial ponds, concrete slabs, ant traps, pots, refrigerator trays or any place in a manner that is congenial for breeding of mosquitoes.

N.B. —This card is a state document and it is a punishable offence to misplace, disfigure and destroy this card.
