YATINUWARA PRADESHIYA SABHA

By Laws

I, Sarath Ekanayake, as the Minister in Charge of the subject of Local Government of the Central Provincial Council, do hereby notify according to the powers vested in me under Sub-section (1) of Section 123 of the Pradeshiya Sabha Act, No. 156, 1987, to be read with Sub-section (1) (a) of Section 2 of the Provincial Council Act, No. 12 of 1989 (Consequential Provisions) has approved the following by-laws framed by the Yatinuwara Pradeshiya Sabha, according to powers vested under Sub-section (e) vii of Section (126) of the said Act, to be read with Sub-section (1) of Section 122 of the Pradeshiya Sabha Act, No. 15 1987 and the said by-Laws shall be effective within the Pradeshiya Sabha authority area of Yatinuwara from the date of publication of this notification in the Government *Gazette*.

BY-LAW RELATING TO PARKING HIRING CARS AND MOTOR VEHICLES

- 01. This by-law is cited as these by-law for parking controlling and regulating hiring cars and motor vehicles within the Yatinuwara Pradeshiya Sabha authority area and for levying licensing fees from such vehicles.
- 02. No motor vehicle shall be parked at any public place for the purpose of hiring such vehicles except at a place approved by the Pradeshiya Sabha of Yatinuwara and duly notified by the Chairman according to 1st Schedule shown herein. Such parking places shall be amended and new parking places shall be named on a resolution passed in the Council.
- 03. Hiring cars and Motor Vehicles shall be parked at places shown in the 1st Schedule hiring, on payment of fees, shown in the 2nd Schedule together with and the relevant crown fees to council annually. Such hiring cars and Motor Vehicles shall be registered in the Council. Relevant Crown fees shall be determined by the Council from time to time and such amended fees shall be valid only after publication of a notification in the Government *Gazette*.

- 04. No person shall park a Motor Vehicle in the parking places shown in the 1st Schedule herein situated within the Pradeshiya Sabha authority area, except on a license issued by the Chairman of the Pradeshiya Sabha or by an officer authorized by him. Such parking arrangement shall operate from 6.00 a.m. to 7.00 p.m. daily. Whenever a new parking place is established according to 1st Schedule the approval of the general Assembly shall be obtained by passing a resolution.
- 05. The period of validity of every license issued under the by-laws shall expire on the last date of the calender month for which it is issued unless it is cancelled ealier by the Chairman or by an Officer authorized by him.
- 06. For the purpose of obtaining a license, as stipulated in the third Schedule herein the owner or driver of the vehicle shall apply to the Chairman by forwarding an application to be obtained from the Pradeshiya Sabha of Yatinuwara.
- 07. The license issued in respect of a Motor Vehicle parked in a parking place shall be produced for inspection of a traffic warden or a person appointed by the Chairman for such purpose whenever a request is made from the owner or driver of such vehicle.
 - 08. Vehicle parking license shall have to be obtained every year before the 31st January of the relevant year.
- 09. No Motor Vehicle shall be parked in a hiring car and Motor Vehicle parking place without a license issued by the Yatinuwara Pradeshiya Sabha.
- 10. Whenever a Motor Vehicle is to be removed from a vehicle parking place permanently or for a period not less than 14 days, such removal shall be immediatly notified to the Council Office and annual fees shall have to be paid even if fail to notify accordingly.
 - 11. No vehicle shall be washed or cause to be washed or repaired within a hiring car and Motor Vehicle parking place.
- 12. No person shall behave under influence of liquor, or misbehave or behave in disorderly manner causing any hindrance inside a hiring car parking place or inside a vehicle therein.
- 13. Contravening any of the provisions of these by-laws is an offence and when convicted in a Court of Law having jurisdiction, the maximum fine, and punishment imposable, and when such contravention is committed continuously and when convicted or in the case of continuous contravention, after delivering a written notice by the Chairman or by any other authorized Officer, drawing attention for such contravention, to maximum additional fine imposable for each day of continuing such contravention shall respectively be as defined under Sub-section (02) of Section (112) of the Pradeshiya Sabha Act, No. 15 of 1987.
- 14. It shall be lawful to cancel a license of a person who has convicted in a Court of Law twice or more times on account of violation of these by-laws and or in addition to any other punishment imposed by a Court of Law having jurisdiction and such person has no right to claim any compensation for such cancellation.
 - 15. Unless the context otherwise requires in these by-laws
 - "Council" means the Yatinuwara Pradeshiya Sabha.
 - "Chairman" menas the Chairman of the Yatinuwara Pradeshiya Sabha.
 - "Traffic Warden" means an Officer appointed by the Pradeshiya Sabha to control traffic.
 - "Motor vehicle or hiring car" means a three wheeler, lorry, motor van., tractor, truck, motor car and hand tractor.
 - "Authorized Officer' means an Officer authorized by the Chairman of Yatinuwara Pradeshiya Sabha.

In the event of any inconsistency in the Sinhala, Tamil and English texts of these by-laws the Sinhala text shall prevail.

- 01. 30 meters on the right side from the junction along Peradeniya Gatambe High Road (9 Hector Kobbekaduwa Road) in the Peradeniya Town.

- 08. 20 meters, commencing at a distance of 25 meters on the left side of road towards Aladeniya at Polgahamula Junction.
 - 09. 20 meters commencing at a distance of 10 meters along the road from Polgahamula. Edanduwawe Junction.
 - 10. 10 meters commencing from the road towards Kehelwala temple at Kehelwala Junction.
 - 11. 20 meters on left side commencing from the road towards Owala at Kiribath-Kumbura Owala Junction.
 - 12. 20 meters on left side commencing at the beginning of Watura-Kumbura Road at the Kiribath-Kumbua Junction.
- 13. 17 meters towards Muruthalawa, from left side of the junction in front of multi-purpose hall along Gannoruwa Muruthalawa Road.
- 14. 12 meters, beginning from the right side towards Pushaparama temple Road at "Patupalama" (narrow bridge) along Gannoruwa Muruthalawa Road.
- 15. 25 meters on the right side, towards Polgahamula from the vicinity of Guadrangular Junction in Muruthalawa Town.
 - 16. 20 meters towards Aladeniya, on the left side close to Rural Bank in Muruthalawa Town.
 - 17. 10 meters towards Muruthalawa Town, commencing from right side of Kambiadiya Junction.
 - 18. 20 meters towards Aladeniya, on the Left side in front of the Mosque, from Yahalatenna Junction.

- 23. 10 meters towards Sooriyagoda, commencing from the left side, at Sooriyagoda Junction, along Kiribathkumbura-Watura Kumbura Road.
- 24. 10 meters towards Watura Kumbura, on the left side, from the bus halting place at Moladanda Junction along Kiribath Kumbura Watura Kumbura Road.
- 25. 10 meters towards Kiribath Kumbura on the left side, from Idampitiya Junction along Kiribath Kumbura-Watura Kumbura Road.
 - 26. 20 meters from left side, towards Pepolanga commencing from Godamuduna Junction.

I, Sarath Ekanayaka, as the Minister in Charge of the subject of Local Government of the Central Provincial, Council de hereby notify according to the powers vested in me under Sub-section (1) of Section 123 of the Pradehiya Sabha Act, No. 156 1987, to be read with Sub-section (1)(a) of Section 2 of the Provincial Council Act No. 12 of 1989 (Consequential Provisions) has approved the following by-laws framed by the Rattota Pradeshiya Sabha, according to powers vested under Sub-section (e) Vii of Section (126) of the said Act, to be read with Sub-section (1) of Section 122 of the Pradeshiya Sabha Act, No. 15 of 1987 and the siad by Laws shall be effective within the Pradeshiya Sabha authority area of Rattota from the date of publishing this notification in the Govrnment *Gazette*.

BY-LAW RELATING TO PARKING HIRING CARS AND MOTOR VEHICLES

- 01. This by-law is cited as the by-law for controlling and regulating the parking of hiring Cars/Motor Vehicles within the Pradeshiya Sabha authority area of Rattota and for levying fees from such vehicles.
- 02. No motor vehicle shall be parked at any public place for the purpose of hiring such vehicles except at a place approved by the Pradeshiya Sabha and duly notified by the Chairman according to 1st Schedule shown herein. Such parking places shall be amended and new places nominated on a resolution passed in the Council.
- 03. Parking registration fees shown in the 3rd schedul shall be charged for vehicles parked in the places, situated within the Rattota Town limits, shown under Sections A,B,C, of the 1st Schedule according to by-Laws relating to parking of hiring cars and vehicles within the Rattota Pradeshiya Sabha authority area.
- 04. Annual registration fees and annual licensing fees shall be charged as shown in the 4th schedule for parking in places, situated within the Pradeshiya Sabha authority area, as shown in the 2nd schedule herein.
- 05. According to these by-laws, the drivers, lessors and owners shall keep with them the receipt issued for payment of daily fees for three wheelers lorries, and motor vans used for hiring, parked within the town limits of Rattota.
- 06. No person shall park motor vehicles in the parking places shown in the 1st schedule herein, situated within the Pradeshiya Sabha authority area, without a license issued by the Chairman or by an Officer authorized by him, and shall be effective from 6.00 a.m. to 7.00 p.m.
- 07. Validity of every licence issued under these by-Laws shall expire on the last day of the calender month for which it is issued unless it is cancelled earlier by the Chairman or by an Officer authorized by him.

- 08. For the purpose of obtaining a licence an application as stipulated in the 3rd Schedule herein issued by Rattota Pradeshiya Sabha shall be forwarded to the Chairman by the owner or driver of the vehicle.
- 09. The owner or driver of a vehicle parked in a parking place, shall produce the licence issued for such vehicle, whenever a traffic warden or person appointed by the Chairman for the purpose, require such licence for inspection.
 - 10. Vehicle parking licence for parking vehicle shall be obtained before the first day of every relevant month.
- 11.No motor vehicle shall be entered into a hiring car/and motor vehicle parking place without a valid licence issued by the Rattota Pradeshiya Sabha.
- 12. If a motor vehicle is to be removed from a hiring car parking place permanently or for a continuous period not less than 14 days, the Council Office shall be notified immediately of such removal. Monthly fee for the relevant month shall have to be paid if fail to notify accordingly.
 - 13. No vehicle shall be washed or cause to be washed or be repaired wihtin a hiring Car/Motor vehicle parking place.
- 14. No person shall behave drunkenly or under influence of liquor or misbehave or behave in disorderly manner causing hindrance inside a hiring parking place or inside a vehicle parked thereon.
- 15. Contravening any of the provisions of these by-laws is an offence and when convicted in a Court of Law having jurisdiction the maximum fine and punishment imposable, and when such contravention is committed continuously and when convicted or in the case of contravention after delivering a written notice by the Chairman or by an officer authorized by him drawing attention for such contravention, the maximum additional fine imposable for each day of continuing such contravention shall respectively be as defined under Sub-section 122 (02) of the Pradeshiya Sabha Act, No. 15 of 1987.
- 16. it shall be lawful for cancelling a licence issued to a person who has convicted in a Court of Law twice or more times on account of violaion of these by-laws and or in addition to any other punishment imposed by a Court of Laws having jurisdiction. Such person has no right to claim any compensation on account of such cancellation.
 - 17. Unless the context otherwise requires in these by-laws
 - "Chairman" means the Chairman of the Pradeshiya Sabha of Rattota.
 - "Authorized Officer" means an Officer authorized by the Chairman of Rattota Pradeshiya Sabha.
 - "Traffic Warden" means a person appointed by the Pradeshiya Sabha Rattota for control of traffic.
 - "Motor Vehicle or hiring car' means and include a Three Wheeler, Lorry, Motor Van, Tractor, Truck, Motor Car and hand tractor.

In the event of any inconsistency in the Sinhala Tamil and English text of these by-laws the Sinhala text shall prevail.
