#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the servitude over the land described below in the 1st column is needed for a public purpose and will be acquired under the provisions of that Act. It describes in the II<sup>nd</sup> column from which land that the servitude will be acquired.

I. Acquisition of servitude of an additional land for the construction of Access Road to Madarangoda Reservoir of the Kandy South Water Supply Project.
