SRI LANKA ELECTRICITY ACT, No. 20 OF 2009

Order under item 3 of Schedule I

BY virtue of the powers vested in me by item 3 of Schedule I of Sri Lanka Electricity Act, No. 20 of 2009, I, Patalie Champika Ranawaka, Minister of Power and Energy, upon the recommendation of the Public Utilities Commission established under the Public Utilities Commission of Sri Lanka Act, No. 35 of 2002 do by this Order :-

- (*a*) approve that the land specified in the Schedule to this Order is required by the Ceylon Electricity Board established under the Ceylon Electricity Board Act, No 17 of 1969, for a public purpose ; and
- (b) may be acquired under the Land Acquisition Act (Chapter 460) and transferred to the Ceylon Electricity Board.
