UVA PROVINCIAL COUNCIL

THE notification made under Section 2(2), subsection 3(a) and 3(a) iii of Charter No. 02 of 2011 on power of supervision and administration of Local Government Institutions of Uva Provincial Council.

I, Shasheendra Rajapaksa, the Chief Minister and the Minister of Finance and Planning, Law and Order, Education, Local Government, Cultural Affairs, Transport, Land, Irrigation, Economic Promotion and Rural Infrastructure Development and Construction, under the powers vested in me, have appointed Mr. Kotuwila Kamkanamalage Gamini Franzis Perera, the retired high court judge of investigate and report on the matters shown under subsection 2(1) (c) and 2(1) (e) of Charter No. 02 of 2011 on the power of supervision and administration of the Local Government Institutions of Uva Provincial Council.

I, Shasheendra Rajapaksa, the Chief Minister and the Minister of Finance and Planning, Law and Order, Education, Local Government, Cultural Affairs, Transport, Land, Irrigation, Economic Promotion and Rural Infrastructure Development and Construction, under the powers vested in me, and under the powers vested in me under Section 3(a) (iii) of Charter No. 02 of 2011 on power of supervision and administration of the Local Government Institutions of Uva Provincial Council, do hereby suspend the functions of Welimada Pradeshiya Sabha in Badulla District, with immediate effect.

As the functions of Welimada Pradeshiya Sabha in Badulla District have been suspended under subsection 3(a) (iii) of 2011 of Charter No. 02 of 2011 on power of supervision and administration of the Local Government Institutions of Uva Province, I do hereby order Mr. Maley Pathiranage Nishantha Mohan Wickramasinghe, the Commissioner of Local Government of Uva Province to execute the powers and carry out the tasks thereof.
