I hereby give notice under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following lands which are required for a public purpose.

Description of the lands to be acquired: PP Co 9125

Three (03) allotments of land in total extent of about 0.0133 Hectare, depicted as Lot Nos. 1, 2, 3 in the Preliminary Plan No. Gam 3888 prepared by the Superintendent of Surveys, Gampaha District for the Surveyor-General, situated in the village called Basiyawatta within Negombo Municipal Council Limit in the Divisional Secretary's Division of Negombo in the District of Gampaha in Western Province and described as follows:
