THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 7

I, hereby give notice under Sub-section (1) of Section 7 of the Land Acquisition Act that the Government intends to acquire the following lands which are required for a public purpose.

Description of the lands to be acquired:

Allotments of the land situated at the Village of Kotapola in the Minor Division of Morawak Korale in the Divisional Secretariat of Kotapola in the District of Matara depicted in Supplementary Sheet No. 74 of the Sheet No. 102 (F.V.P. 45) prepared by the Surveyor-General and containing in extent about 3.2666 Hectares and boundaries of that lands given below:

01. Lot No. 2178 – Hangaran kanda Warallawatta *alias* Yajlandi Watta – Extent: About 2.3053 Hectares

North: Lot No. 595; East: Lot Nos. 595 and 596; South: Lot No. 596 and Road; West: Road and Lot Nos. 596 and 595.

02. Lot No. 2179 Koodaluhena Deniya – Extent: About 0.9035 Hectare

North: Main Road and Lot No. 597; East: Lot No. 597 and Road;

South: Road and Lot Nos. 597 and 2180; West: Lot Nos. 2180, 597 and Road.

03. Lot No. 2180 – Andaramullawatta, Koodaluhedeniya, Denipillehena – Extent: About 0.0578 Hectare
