### **Provincial Councils Notifications**

#### WESTERN PROVINCE PROVINCIAL COUNCIL

Inquiry held under the Section 2 of the Powers of Supervision of the Administration of Local Authorities Statute, No. 04 of 1991 of the Western Province Provincial Council

I, Prasanna Ranatunga, the Chief Minister and the Minister of Finance and Planning, Law and Order, Education, Land, Local Government and Provincial Administration, Electricity and Power, Manpower and Employment and Economic Promotion of the Western Province Provincial Council do hereby appoint the retired Judge of High Court Hon. Dudley Karunarathne as Single Person Tribunal of Inquiry as per the powers entrusted to me by the provisions of the Section 2(2) of the Powers of Supervision of the Administration of Local Authorities Statute No. 04 of 1991 of the Western Province Provincial Council, to inquire and submit a report within 03 months based on the following matters/allegations, whether the Kelaniya Pradeshiya Sabha, in the course of its functioning, has made the offences stated under Section 2(1) of the aforementioned Statute.

Matters/allegations to be inquired about :

- (a) In the course of its functioning, the Kelaniya Pradeshiya Sabha committing the offences stated in Section 2(1)(a) and/or 2(1)(d) of the Powers of Suprevision of the Administration of Local Authorities Statute, No. 04 of 1991 of the Western Province Provincial Council by allowing the weekly fair of Kiribathgoda owned by the Kelaniya Pradeshiya Sabha to be maintained without a contract to the person named K. G. D. Thilakasiri of No. 162/2, Dalupitiya, Kadawatha for the time period of 01st August, 2011 to 31st December 2011 and thereby acting contrary to Section 173 of Pradeshiya Sabha Act, No. 15 of 1987.
- (b) In the course of its functioning the Kelaniya Pradeshiya Sabha committing the offence/offences stated in Section 2(1)(a) and/or 2(1)(d) of the Powers of Suprevision of the Administration of Local Authorities Statute, No. 04 of 1991 of the Western Province Provincial Council by adopting on 29th July 2011 Rupees Four Hundred Thousand as the minimum bid to a sales outlet at the Trade Complex of Hunupitiya owned by the Kelaniya Pradeshiya Sabha without calling tenders to the previous adoption by the same Pradeshiya Sabha adopted on 30th November 2010 wherein it had been adopted that the minimum bid for a sales outlet at the aforesaid market complex to be Rupees One Million Two Hundred Thousand.
- (c) In the course of its functioning, the Kelaniya Pradeshiya Sabha committing the offence/offences stated in Section 2(1)(a) and/or 2(1)(d) of the Powers of Supervision of the Administration of Local Authorities Statute, No. 04 of 1991 of the Western Province Provincial Council by taking action to call tenders having adopted without proper estimation Rupees Four Hundred Thousand as the minimum bid per one sales outlet applicable for sixteen such sales outlets of Hunupitiya Trade Complex owned by the Kelaniya Pradeshiya Sabha.

  - (d) In the course of its functioning the Kelaniya Pradeshiya Sabha committing the offences stated in Section 2(1)(a) of the Powers of Supervision of the Administration of Local Authorities Statute, No. 04 of 1991 of the Western Province Provincial Council by taking action to proceed with the adoption made on 27th July 2011 by the Kelaniya Pradeshiya Sabha that the minimum bid per one sales outlet from the sixteen sales outlets available in Hunupitiya market complex to be Rupees Four Hundred Thousand when the said Pradeshiya Sabha had previously adopted Rupees One Million Two Hundred Thousand as the minimum bid per a sales outlet mentioned above and thereby causing a loss of Twelve Million Eight Hundred Thousand Rupees or an amount equal to that to the Kelaniya Pradeshiya Sabha.

Further, according to the provisions stated extensively in Section 2(2) of the Powers of Supervision of the Administration of Local Authorities Statute, No. 04 of 1991 of the Western Province Provincial Council, this single party tribunal shall comprise the powers entrusted to a Commissioner appointed under the Inspection Committee Act and it is hereby stated further that written and oral evidence identified as applicable when investigating the above stated matters have been included into the schedule below.
