#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for widening of Olagama Road to 12 feet and will be acquired under the provisions of that Act.

**THE LAND ACQUISITION ACT (CHAPTER 460)****Declaration under Section 5**
