THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the servitude over the land described below under the 1st paragraph is needed for a public purpose and will be acquired under the provisions of that Act. It describes under the 2nd paragraph from which land, that the servitude will be acquired.

1. **Description of the Servitude.**— Acquisition of servitude over the land for the Access Road to Pothgoda Water Tank and Laying of Pipes, of the Marassana Water Supply Scheme.

2. **Description of the Land.**— The allotment of land called "Galapita Hena" in total extent of about 0.0054 Hectare, depicted in the Advance Tracing No. Maha/PTH/2011/384P, dated 13.06.2012, prepared by the Surveyor-General, situated in the Village of Pothgoda in Hewawissa Korale Minor Division in the Divisional Secretary's Division of Pathahewaheta in Kandy District, Central Province and bounded as follows;
