FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE VALVETITHURAI URBAN COUNCIL UNDER SECTION 65A (2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS, the office of a member in Valvetithurai Urban Council has fallen vacant by reason of being elected as a member of the Northern Province Provincial Council :

**FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE JAFFNA MUNICIPAL COUNCIL
UNDERSECTION 65A (2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)**

WHEREAS, the office of a member in Jaffna Municipal Council has fallen vacant by reason of not attending three consecutive meetings without permission :
