WESTERN PROVINCE PROVINCIAL COUNCIL

Rules under Sections 7(1) - (2) and 30 of the Western Province Provincial Road Passenger Transport Services Statute No. 1 of 1992 and Sections 5-6 of the Western Province Provincial Road Passenger Transport Services (amendment) Statute No. 3 of 1993

ACCORDING to the authority and Provisions delegated to me by the 7(1) - (2) and 30 of the Western Province Provincial Road Passenger Transport Services Statute No. 1 of 1992 and Sections 5 and 6 of the Western Province Provincial Road Passenger Transport Services (amendment) Statute No. 3 of 1993, and in order to provide more efficient services to the passengers who are travelling in the private buses that are in the transportation services within the Western Province, I notify that the regulations formulated are as follows.

The following regulations are introduced and implemented within the Western Province from 01st of November 2013 on the usage of modern technology in order to regulate the transportation services of private buses that are in services with the Western Province.

ENFORCEMENT OF REGULATIONS

- * Facilities shall be provided to use electronic ticket issuing machines, which have obtained the approval of the Authority, in the buses, in order to facilitate the usage of prepaid cards by the passengers.
- * GPS technology, which has obtained the approval of the Authority, shall be fixed in the buses enabling the substitution of modern technology in order to facilitate efficient bus transportation services.
- * The driver and the conductor of the bus (employees) shall be included to a social security pension scheme which is approved by the Authority,
