THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Allotments of land, depicted in the Advance Tracing No. Gam/Dom/2013/218 dated 15.07.2013 prepared by the Surveyor General situated in the Villages of Pugoda, Meniklanda in the Minor Division of Siyane Korale in the Divisional Secretary's Division of Dompe, of Gampaha District in the Western Province and bounded as follows:

North: Footpath; East: Road; South: Lot F and Kebellagas Owita claimed by B. Chandrika Priyanthi and L. D. Sanjeewa Kithsiri; West: Balance portion of same land.

06. Lot 'F' - Kebellagas Owita - Extent : 0.0029 Hectare

North: Kebellagas Owita claimed by G. Prasantha Kumara and Lot E; East: Road; South: Lot G and Kebellagas Owita claimed by S. S. Priyantha Mudalige; West: Balance portion of same land.
