##### FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE JAFFNA MUNICIPAL COUNCIL UNDER SECTION 65A(2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of a member in Jaffna Municipal Council has fallen vacant by reason of being elected as a member of the Northern Province Provincial Council ;
