#### SRI LANKA ELECTRICITY ACT, No. 20 OF 2009

##### Order under Section 52

BY VIRTUE of the powers vested in me by Section 52 of the Sri Lanka Electricity Act, No. 20 of 2009 and upon the recommendations made by the Minister in charge of the subject of Power and Energy I, Mahinda Rajapaksa, President of the Democratic Socialist Republic of Sri Lanka being of the opinion that –

- (a) the land specified in the Schedule hereto is urgently required for the construction of a Power Transmission Project ; and
- (b) the said Power Transmission Project being a public purpose would serve for the general welfare and benefit of the public,

do by this order declare that the said land is required for such purpose.
