##### FILLING OF A VACANCY IN THE OFFICE OF VICE CHAIRMAN OF THE WENNAPPUWA PRADESHIYA SABHA UNDER SECTION 65A(1) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of a Vice Chairman in Wennappuwa Pradeshiya Sabha has fallen vacant by reason of being elected as a member of the North Western Province Provincial Council ;

And whereas the Secretary of the United People's Freedom Alliance , the recognised political party to which Trewin Fernando the Vice Chairman belonged, was required by me under Section 65A (1) of the aforesaid Ordinance, to decide upon the member of that Wennappuwa Pradeshiya Sabha who belongs to such party who shall be declared elected as Vice Chairman within a period of thirty (30) days;

**FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE NATTANDIYA PRADESHIYA SABHA

ORDINANCE (CHAPTER 262)**
