Direction under Section 10(1)

ACTING under the powers vested in it by Section 10(1) of the Consumer Affairs Authority Act, No. 09 of 2003, the Consumer Affairs Authority directs all Incense/Joss Sticks Manufacturers, Importers and Traders that they shall mark the Maximum Retail Price, Batch Number, Expiry Date, Net Weight and the name and address of the Manufacturer and/or the Importer on the pack or on the container or on the wrapper of all Incense/Joss Sticks manufactured/imported by them.

This Direction shall come into effect from 1st July 2014.

Direction under Section 12(2)

ACTING under the powers vested in it by Section 12(2) of the Consumer Affairs Authority Act, No. 09 of 2003, the Consumer Affairs Authority directs that no Manufacturer, Distributor or Trader shall manufacture, distribute, store or sell or display for



sale, expose for sale or offer for sale, wholesale or retail any locally manufactured items as described in Columns 1 and 2 below, unless they bear the SLS Product Certification Mark issued by the Sri Lanka Standards Institution ;

ACTING under the powers vested in it by Section 12(2) of the Consumer Affairs Authority Act, No. 09 of 2003, the Consumer Affairs Authority directs that no Manufacturer, Distributor or Trader shall manufacture, distribute, transport, store, sell, expose for sale or offer for sale in wholesale or in retail any locally manufactured Mosquito Coils or Mosquito Mats unless the SLS Product Certification Mark issued by the Sri Lanka Standard Institution is legibly printed in a conspicuous place on each and every pack of such Mosquito Coils and Mosquito Mats.
