THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Allotments of land in extent of about 0.5207 Hectare, indicated as Lots 'G - M' in the Advance Tracing No. MR/DKW/2012/459 dated 09th February, 2013, prepared by the Surveyor-General, situated in the Villages of Bambaranda Central and Bambaranda - South, Wallabadapattuwa East Minor Division, Divisional Secretariat Dickwella in Matara District of Southern Province.
