**MINUTE OF THE SRI LANKA INLAND REVENUE SERVICE**

THE Public Service Commission has granted approval to make following amendments to the *Gazette Notification* of the Minute of the Sri Lanka Inland Revenue Service which was published in the *Extraordinary Gazette* No. 1804/50 dated Friday, April 5th, 2013.

*Paragraph  
No.*

*Proposed Amendment*

- 19.3 (i) Should have completed thirteen (13) years of service which aggregates the periods of service completed in Class II Grade II, Class II Grade I as per the previous Service Minute and in Grade II as per this Service Minute. Such period of service should include an active and satisfactory period of service of three years (03) in Grade II.

*Note :-* For the purpose of the active and satisfactory period of service of three years (03) in Grade II hereof,

1. three years (03) of an active and satisfactory period of service in Class II Grade I under the previous Service Minute; or
2. three years (03) of an active and satisfactory period of service in Grade II under the new Service Minute; or
3. the aggregate of three years (03) of an active and satisfactory period of service of (1) and (2) above would be considered.

- 19.3 (ii). Should have passed first and second departmental examinations as set out in previous Service Minute which existed prior to coming into force of this Service Minute.

*Note of 19.4 :-* For promotion to the Special Grade under the interim provisions set out in paragraph 19.4 above, officers who have completed 25 years of active service in Grade II-II and above of the Sri Lanka Inland Revenue Service will be exempt from

acquiring the post graduate requirement stipulated in Section 11.3.1(i). This concession will be in force as from 01.10.2012 to 31.12.2015.

Where promotions are made to vacancies in the Special Grade falling during the period from 01.01.2016 to 01.01.2018, those officers who submit a written theses accepted by a Board of Adjudication appointed by the Secretary to the Ministry of Finance will be exempt from the requirement of completing the post graduate qualification stipulated in Section 11.3.1(i).

The English translation of the amendment made to the Minute of the Sri Lanka Inland Revenue Service which was published in the Extraordinary Gazette Notification No.1819/44 dated Friday, July 19th, 2013 is hereby rescinded.
