Where the budget document relevant for year 2014 of a certain Pradeshiya Sabha within the Western Province was not adopted according to the provisions stated in Cluase 168 of the Pradeshiya Sabha Act, No. 15 of 1987, and as per Clause 17 of the Local Government Authorities (Special Provisions) Act, No. 21 of 2012 when the Chairman's Office of the relevant Pradeshiya Sabha has become vacant wherein action has not been taken as per provisions of the Local Government Authorities Elecctions (Amendment) Act, No. 22 of 2012 to fill the Chairman's office that has become vacant or when a Chairman newly appointed to the vacant position requires to present a proposal to the Council in relation to adoption of a budget document for year 2014, however, lacks the minimum days to present such proposal to the Council in compliance to



the written law relevant to that, in such case, it is legal to execute certain budget document prepared for year 2014 by the said Pradeshiya Sabha under the approval of the Assistant Commissioner of Local Government Authorities of the district where the relevant Pradeshiya Sabha is located.

3. All the provisions stated in this order shall be put into effect according to the provisions of the Local Government Authorities (Special Provisions) Act, No. 21 of 2012 and Local Government Authorities Elections (Amendment) Act, No. 22 of 2012.

Where the budget document relevant for year 2014 of a certain Urban Council within the Western Province was not adopted according to the provisions stated in Section 178 of the Urban Councils Ordinance (Authority 255), and as per Clause 12 of the Local Government Authorities (Special Provisions) Act, No. 21 of 2012 when the Chairman's Office of the relevant Urban Council has become vacant wherein action has not been taken as per provisions of the Local Government Authorities Elections (Amendment) Act, No. 22 of 2012 to fill the Chairman's office that has become vacant or when a Chairman newly appointed to the vacant position requires to present a proposal to the Council in relation to adoption of a budget document for year 2014, however, lacks the minimum days to present such proposal to the Council in compliance to the written law relevant to that, in such case, it is legal to execute certain budget document prepared for year 2014 by the said Urban Council under the approval of the Assistant Commissioner of Local Government Authorities of the district where the relevant Urban Council is located.

3. All the provisions stated in this order shall be put into effect according to the provisions of the Local Government Authorities (Special Provisions) Act, No. 21 of 2012 and Local Government Authorities Elections (Amendment) Act, No. 22 of 2012.
