#### THE CIVIL AVIATION ACT, No. 14 OF 2010

#### Order Under Section 6

#### APPOINTMENT OF SERVICE PROVIDERS

BY virtue of powers vested in me as the Minister of Civil Aviation under Section 6 of the Civil Aviation Act, No. 14 of 2010, I Piyankara Jayaratne, do hereby appoint, subject to the terms and conditions stipulated in the Schedule - I hereto, the Statutory Service Provider appointed under the aforementioned Act, and published in the *Extraordinary* Government Gazette Notification Number 1727/12 dated 13th October 2011 as the Service Provider for providing the Aeronautical Services as specified in the Schedule - II hereto.

#### SCHEDULE - I

#### TERMS AND CONDITIONS OF APPOINTMENT

1. In providing the Aeronautical Services specified in Schedule - II, the Statutory Service Provider shall conform to the applicable legal provisions in the Civil Aviation Act, No. 14 of 2010 and Regulations, Rules or Implementing Standards made thereunder or any other written law ;

2. The Statutory Service Provider shall comply with any general or special directions given by the Minister in writing from time to time as to the discharge of functions of the Statutory Service Provider ;

3. The statutory Service Provider shall maintain in good order all movable and immovable properties which it holds for and on behalf of the State for the wellbeing and development of air transport industry and shall not grant such immovable property on lease to a third party for any period in excess of ten (10) years without prior consent in writing from the secretary to the Ministry of the Minister ;

4. Every contract entered into by the Statutory Service Provider after the date hereof in respect of any Aeronautical Service provided by the Statutory Service Provider, shall unless there is express provision to the contrary in the terms of such contract, be deemed to be a contract entered into by the Statutory Service Provider on his own behalf and not on behalf of the State and shall not bind the State in any manner ;

5. On demand by the Secretary to the Ministry of the Minister in writing, the Statutory Service Provider shall furnish to the Secretary, with all relevant information concerning any administrative, operational, technical or financial matters pertaining to the aeronautical services provided ;

6. The Statutory Service Provider shall comply with the applicable requirements stipulated by the Civil Aviation Authority of Sri Lanka or Director General of Civil Aviation as the case may be and obtain requisite licences or certificates as applicable, for provision of aeronautical services specified in the Schedule - II ensuring that such services are maintained in conformity with the applicable international standards and recommended practices ;

7. The Statutory Service Provider shall not alter, suspend or stop provision of any aeronautical service mentioned in Schedule - II without approval from the Minister in writing ;

8. It is the duty of the Statutory Service Provider to arrange a sufficient insurance cover to meet the potential liabilities or compensations that may arise during its operations and the State will not be liable for such liabilities or compensation ;

9. The change of corporate identity, share capital or name of the Statutory Service Provider requires prior approval of the Minister in writing ;

10. The Statutory Service Provider shall not transfer or sublease provision of any of the aeronautical services specified in Schedule - II without written approval by the Minister.

#### *SCHEDULE - II*

##### *Aeronautical Services to be Provided by the Statutory Service Provider*

1. The Development, operation and maintenance of ;

- (i) Bandaranaike International Airport, Colombo in the Western Province ;
- (ii) Mattala Rajapaksa International Airport in the Southern Province ;
- (iii) Colombo Airport, Ratmalana, in the Western Province ;

and any other aerodrome to be specified by the Minister in terms of an Order published in the *Gazette* from time to time.

2. The Provision and maintenance of Search, Rescue and Firefighting Services at the aerodromes specified in (1) above and at any other aerodrome to be specified by the Minister in terms of and Order published in the *Gazette* from time to time.

3. The provision and maintenance of Aviation Security service at the aerodromes specified in (1) above and at any other aerodrome to be specified by the Minister in terms of an Order published in the *Gazette* from time to time.

4. The provision of Air Traffic Services.

5. The provision of Aeronautical Information Services.

6. The provision of Aeronautical Communication Services.

7. The provision of Aeronautical Aids for Communication, Navigation or Surveillance.
