### Government Notifications

#### CUSTOMS NOTIFICATION OF THE GOVERNMENT

##### Order under Section 111 of the Customs Ordinance (Chapter 235)

BY virtue of the powers vested in me under Section 111 of the Customs Ordinance (Chapter 235) to be read with Article 44(2) of the Constitution of the Democratic Socialist Republic of Sri Lanka, subject to Air Navigation Regulations No. 09 of 1938, I, Mahinda Rajapaksha, President of the Democratic Socialist Republic of Sri Lanka, do by this notification order and declare that the village of Maththala in Hambanthota District in the Southern Province to be an Airport of the Democratic Socialist Republic of Sri Lanka and its respective boundaries shall be as set out in the Schedule “A”, I do further declare the places set out in the Schedule “B” to be a legal Airport within such boundaries for loading and unloading of air passengers, air mail items and other cargos and declare the boundaries and extent of such Airport shall be as set out in the Schedules “A” “B” and “C” within the Maththala Rajapaksa International Airport.
