I, Gustingnawadu Shan Wijayalal de Silva, the Chief Minister and the Minister of Finance, Planning, Law and Order, Transport, Water Supply and Drainage, Electricity, Engineering Services, Health, Indigenous Medicine and Local Government of the Southern Province Provincial Council, do hereby rescind the regulations made by me relevant to the travelling expenses of Chairmen, Vice Chairmen and Members of Urban Councils and published in the *Gazette Extraordinary* No. 1780/20 dated 18.10.2012 of the Democratic Socialist Republic of Sri Lanka.

Further, under the powers vested in me in terms of Section 193(2)(h) of the Urban Councils Ordinance (Chapter 255) read with Section 2 of the Provincial Councils (Ancillary Provisions) Act, No. 12 of 1989, I, hereby impose the following regulations made by me pertaining to the travelling expenses of Chairmen, Vice Chairmen and Members of the Urban Councils. These regulations shall take effect from 01.01.2012.

REGULATIONS

01. These regulations may be cited as regulations on the payment of travelling expenses for Chairmen, Vice Chairmen and Members of the Urban Councils.

- 02. A Chairman, Vice Chairman or member of an Urban Council who uses his own vehicle or any mode of public transport on his official functions as a people's representative or on any functions assigned to him by the council, may be paid a travelling allowance subject to a maximum of Rs. 3000.00 per month, as a reimbursement of travelling expenses incurred by him.
- 03. If the motor car/three wheeler or the motor cycle so used is not his own, it could be treated as own vehicle if the following documents relating to the motor car/three wheeler or the motor cycle concerned, are produced.
 - (i) Certified copy of the certificate of registration;
 - (ii) Certified copy of the annual revenue licence;
 - (iii) Certified copy of the valid insurance certificate; and
 - (iv) An affidavit sworn by the owner of the vehicle authorising the use of the motor car/three wheeler or the motor cycle concerned.
- 04. The fuel bills or if the travelling was undertaken by public transport, the relevant bills, shall be submitted when claiming the travelling allowance.
- 05. The approval of the council shall be obtained before the payment of the said travelling allowance and financial provision shall have been provided for the purpose in the annual budget of the council.

A Mayor, Deputy Mayor or member of a Municipal Council who uses his own vehicle or any mode of public transport on his official functions as a people's representative or on any functions assigned to him by the council, may be paid a travelling allowances ubject to a maximum of Rs. 3000.00 per month, as a reimbursement of travelling expenses incurred by him.
- 03. If the motor car/three wheeler or the motor cycle so used is not his own, it could be treated as own vehicle if the following documents relating to the motor car/three wheeler or the motor cycle concerned, are produced.
 - (i) Certified copy of the certificate of registration;
 - (ii) Certified copy of the annual revenue licence;
 - (iii) Certified copy of the valid insurance certificate; and
 - (iv) An affidavit sworn by the owner of the vehicle authorising the use of the motor car/three wheeler or the motor cycle concerned.
