PART I : SECTION (I) — GENERAL

CIVIL AVIATION ACT, No. 14 OF 2010

REGULATIONS made by me, the Minister of Civil Aviation by virtue of powers vested in me under Section 117(q) of the Civil Aviation Act, No. 14 of 2010.

Regulations

1. These Regulations may be cited as the charges for the use of aerodrome at the Mattala Rajapaksa International Airport and come into effect on the date of issue.
2. By these Regulations the Regulations published by the *Extraordinary Gazette* Notification No. 1801/38 dated 15th March 2013 shall stand cancelled.
3. Unless otherwise exempted by Director General of Civil Aviation in writing.

Every aircraft landing at the Mattala Rajapaksa International Airport shall pay the flowing Landing and Parking Charges to the Statutory Service provider.

| 1. | Landing Charges | Four (4) United States Dollars for every one thousand kilo grammes or part thereof the maximum take-off weight of the aircraft |
| 2. | Parking Charges | Ten (10) per centum of the applicable Landing Charge for each period of six (6) hours or part thereof in excess of the first three (3) hours of parking |

4. Notwithstanding the Landing and Parking Charges specified in paragraph “3” above, the following limited categories of operators will be afforded with promotional discount rates stated below with regard to the applicable Landing and Parking Charges with immediate effect.



The limited categories of operators aforesaid are

- (a) New Charter Flight Operators ;
- (b) New Budget Carriers ;
- (c) Present Budget Carriers operating to BIA, for any additional frequencies to MRIA ;
- (d) Present Legacy Carriers operating to BIA, for any additional frequencies to MRIA ;
- (e) New Legacy Carriers.
