**FINANCE ACT, No. 11 OF 1963**

**Order under Section 72**

1. All that divided and defined allotment of amalgamated land marked as Lot 4 of Bandarawatte, Beligahawatte and Ambalammullewatte situated at Anwarama in Colombo–Kandy road, within the town Council Limits of Mawenella, Uthuwankanda Electorate in Egodapatha, Thanipperu Pattu of Galbode Korale in the District of Kegalle, Sabaragamuwa Province and bounded on the North and East by Lot 3 of plan No. 3090 dated 02.06.1973 made by L. A.
