#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of land shown as Lot Nos. 1 - 4 in extent of about 0.0623 Hectare, indicated in Advanced Tracing No. CO/HNW/2012/1125 and dated 28.02.2013 prepared by the Surveyor-General situated in the Village of Brandigampala in the Minor Division of Medapattu in Divisional Secretary's Division of Seethawaka (Hanwella) in the Colombo District in Western Province and bounded as follows:
