THE LAND REFORM LAW, No. 1 OF 1972 OF NATIONAL STATE ASSEMBLY

Order under Sub-section (4) of Section 27A

BY virtue of the powers vested in me by Sub-section (4) of Section 27A of the Land Reform Law, No. 1 of 1972 as amended by the Land Reform (Special Provisions) Act, No. 39 of 1981, read with paragraph (2) of Article 44 of the Constitution of the Democratic Socialist Republic of Sri Lanka, I, Mahinda Rajapaksa, President, do hereby -

- (a) Amend the Order, made under Sub-section (1) of Section 27A of the aforesaid Act, and published in *Gazette Extraordinary* No. 344/5 of April 09, 1985 relating to the land called and known as Yatawahara *alias* Yatawahara morefully described in the First Schedule to this order and which had vested in the Janatha Estate Development Board established by the State Agricultural Corporation Act, No. 11 of 1972, by revoking on grounds of non-compliance with such terms and conditions relating to consideration for the vesting in such Board, such portion of the said Order as relates to the extent of land called Yatawahara *alias* Yatawahara specified in the Second Schedule; and
- (b) State that upon revocation, such extent of land as specified in the Second Schedule to this order, shall re-vest in the Land Reform Commission.
