Notification

THE COCONUT GROWING TRADE

IN accordance with the provisions of Section 28 of the Wages Boards Ordinance (Chapter 136), the Wages Board for the Coconut Growing Trade hereby notifies that the Board by virtue of the powers vested in it by Section 30 of the aforesaid Ordinance proposes to vary in the manner set out in the Schedule hereto, such decisions of the Board as are specified in that Schedule.

Objections to the aforesaid proposal will be received by the Chairman of the Board until 12.00 noon on 24th September 2013.

Every such objection must be made in writing and must contain a statement of the grounds upon which such objection is taken.

SCHEDULE

The decisions made by the Wages Board for the Coconut Growing Trade, and set out in the Schedule to the Notification published in the *Gazette Extraordinary* No. 9971 of 30th April, 1949 as varied from time to time, and last varied by the Notification published in *Gazette Extraordinary* No. 1747/5 of 28th February 2012 shall be further varies as follows -

(1) In Part II of that Schedule in the minimum wage for piece work applicable to the workers shall be as follows :

	<i>Process</i>	<i>Rate (Rs.)</i>
(1)	In the raising and maintenance of Plantation plucking nuts -	1655.00 per 1000 trees
(2)	In the manufacture of Copra-Husking nuts, Splitting nuts, Copra curing and sorting -	485.00 per 1000 nuts

PART III

(2) Processes :

- (a) The raising and maintenance of a Coconut Plantation ;
- (b) The manufacture of Copra.

The minimum rate of wages for time work in relation to above processes shall be :

For all worker - Rs. 415.00 Per day

Notwithstanding anything to the contrary contained in the preceding provision of this Part, the minimum rate of wages for time work for any worker engaged in cattle keeping on Sunday shall be one and a half times the minimum rate of wages for the work fixed for such worker in respect of a normal working day.

PART III "A"

The minimum rate of wages for time work in relation to :

- (a) the work of a Conductor ;
- (b) the work of a Watcher shall be.

SCHEDULE

The Wages board for the Flowers, Ornamental Plants, Vegetables and Fruits Growing and Export Trade propose to take decisions on the minimum rates of wages as indicated in Part II, in respect of worker Categories mentioned in Part I that made by the aforesaid Wages Board and set out in the schedule to the Notification published in *Gazette Extraordinary* No. 1748/16 of 09th March 2012.

PART I

Skilled :

Tissue and seed Cultivators, workers engaged in grafting, workers engaged in arranging flower plants, flowers and branches for export and sale, workers engaged in arranging ornamental plants and parts of plants, Quality Controllers, workers engaged in spraying fungicides, insecticides and Manuaring, packers, Store Keepers, Men in charge of workers Administration, workers engaged in activities which need a training.

Semi-Skilled :

Workers engaged in preparation of nursery beds, planting seedlings and maintenance, product Pluckers and Collectors, Store assistants other Semi-Skilled workers.

Un Skilled :

Workers engaged in preparation of land, Loading and un-loarding Labourers, workers engaged in other acivities which do not need a training.
