THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Allotments of land in extents and the names depicted in Advance Tracing No. CO/THI/2012/1128 of 02.05.2013, prepared by the Surveyor-General, situated in the Village of Pamankada-East (Within the limits of Colombo Municipal Council, Division number 45) in Thimbirigasyaya Divisional Secretary's Division, Colombo District Western Province, the boundaries are as follows:
