### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of land in extent of about 0.1848 Hectare, depicted in Advance Tracing No. Gam/Gam/2014/122 and dated 21.05.2014, situated in Minor Division of Medapattuwa in the Village of Ihala Imbulgoda in Divisional Secretary's Division of Gampaha in the Gampaha District in Western Province and bounded as follows:
