3. (1) In the following occasions, a Mayor, Deputy Mayor and Councilor of a Municipal Council shall not be liable to receive the above allowance.
- Non-participation at council meetings and committee meetings of the month related to the allowance-payment without obtaining the approval of the Council.
  - Has flown out of country on a personal matter, external to council duties.
  - Being jailed or in custody on certain criminal charge.
- (2) Notwithstanding the matters stated in Sub-paragraph (i) of Paragraph (1) of this order, where a Mayor, Deputy Mayor or Councilor engage in official duty on formal approval, he shall not be deprived of his allowance on the reason of non-participation at council meetings.
