#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Three (03) allotments of land containing in extent of about 0.8093 Hectare (A:02, R: 0, P:0), depicted as Lots. A, B and C in Advance Tracing No. MR/HKM/2013/661 prepared by Surveyor General and situated in the Village of Vepathaira in Divisional Secretary's Division of Hakmana, in Matara District and bounded as follows.
