**FILLING OF A VACANCY IN THE OFFICE OF VICE CHAIRMAN OF THE  
VALIKAMAM WEST PRADESHIYA SABHA  
UNDER SECTION 65A(1) OF THE  
LOCAL AUTHORITIES ELECTIONS ORDINANCE  
(CHAPTER 262)**

**AS AMENDED BY LOCAL AUTHORITIES (SPECIAL PROVISIONS) ACT, No. 30 OF 2013**

WHEREAS the office of Vice Chairman in Valikamam West Pradeshiya Sabha has fallen vacant by reason of not attending meetings of the Council for a period of three months without permission ;

AND WHEREAS the Secretary of the Ilankai Tamil Arasu Kadchi, the recognised political party to which Navaratnam Sivarajan the former Vice Chairman belonged, was required by me under Section 65A(1) of the aforesaid Ordinance, to decide upon the member of that Valikamam West Pradeshiya Sabha who belongs to such party who shall be declared elected as a Vice Chairman within a period of thirty (30) days ;

AND WHEREAS the Secretary of the aforesaid recognised political party has communicated his decision to Mr. Navaratnam Sivarajan fill such vacancy ;

NOW THEREFORE I, Ponnuththurai Kuganathan, Returning Officer of Valikamam West Pradeshiya Sabha, acting in terms of Section 65A(1) of the Local Authorities Elections Ordinance as amended by Filling of Vacancies in Local Authorities (Special Provisions) Act, No. 30 of 2013 (Chapter 262) do hereby declare Mr. Navaratnam Sivarajan elected as Vice Chairman of the Valikamam West Pradeshiya Sabha.
