#### FINANCE ACT, No. 11 OF 1963

#### Order under Section 72

BY virtue of the powers vested in me by Section 72 read with Section 71 of the Finance Act, No. 11 of 1963 as amended from time to time, read with Article 44(2) of the Constitution, I, Mahinda Rajapaksa, President, do by this Order, vest in the People's Bank established under the People's Bank Act, No. 29 of 1961, with effect from 17th December Two Thousand and Fourteen, the properties described in the Schedule hereto.

#### **SCHEDULE**

1. All that divided and defined allotment of land marked as Lot 1 of one second share in Western side divided by the Plan No. 2971 dated 27.08.1964 made by B. S. A. Kroon, Licensed Surveyor, of the land called "Putukaule Hena" in extent of fifteen seers of Kurakkan, *i. e.* land in extent of four acres Two Roods and Twenty Six perches (4A., 2R., 26P.) depicted in Plan No. 2974 dated 25.08.1964 made by K.
