NORTHERN PROVINCE PROVINCIAL COUNCIL

ORDER under Section 223 of the Pradeshiya Sabhas Act, No. 15 of 1987 read with Section 2 of the Provincial Councils (Consequential Provisions) Act, No. 12 of 1989.

I, C. V. Wigneswaran, the Chief Minister and the Minister of Finance and Planning, Law and Order, Lands, Road Development, Electricity, Housing and Construction, Water Supply, Co-operative Development, Social Service and Rehabilitation, Women's Affairs, Industries and Enterprise Promotion, Tourism, Local Government and Provincial Administration and Food Supply and Distribution of Northern Province, do hereby make Order as described in the Schedule hereto by virtue of power vested in me under Section 223 of the Pradeshiya Sabhas Act, No. 15 of 1987 read with Section 2 of the Provincial Council (Consequential Provisions) Act, No. 12 of 1989.

Order

1. This order shall be named as the Order to enforce the budget document for year 2014 of the Pradeshiya Sabhas of the Northern Province Provincial Council.

2. Where the budget document relevant for year 2014 of a Valli East Pradeshiya Sabha within the Northern Province was not adopted according to the provisions stated in Clause 168 and 169 of the Pradeshiya Sabha Act, No. 15 of 1987, and as per Clause 17 of the Local Government Authorities (Special Provisions) Act, No. 21 of 2012 when the Chairman's office of



the relevant Pradeshiya Sabha has become vacant wherein action has not been taken as per provisions. of the Local Government Authorities Elections (Amendment) Act, No. 22 of 2012 to fill the Chairman's office that has become vacant or when a Chairman newly appointed to the vacant position requires to present a proposal to the Council in relation to adoption of a budget document for year 2014. However, lacks the minimum days to present such proposal to the Council in compliance to the written law relevant to that, in such case, it is legal to execute certain budget document prepared for year 2014 by the said Pradeshiya Sabha under the approval of the Secretary of Valli East Pradeshiya Sabha.

3. All the provisions stated in this order shall be put into effect according to the provisions of the Local Government Authorities (Special Provisions) Act, No. 21 of 2012 and Local Government Authorities Elections (Amendment) Act, No. 22 of 2012.
