#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Two (02) allotments of land in total extent of about 0.427 Hectare, depicted in Advance Tracing No. 2006/107 of 12.07.2006 prepared by the Surveyor General of Badulla District. The Lots A and B called Sapumaltenna *or* Wetahirewatta situated in the Village of Ella Town in the Minor Division of Kumbalwela Korale in the Divisional Secretary's Division of Ella in Badulla District, Uva - Province and bounded as follows:

01. Lot 'A' – Sapumaltenna *or* Wetahirewatta – Extent: About 0.042 Hectare
