FINANCE ACT, No. 11 OF 1963

Order under Section 72

BY virtue of the powers vested in me by Section 72 read with Section 71 of the Finance Act, No. 11 of 1963 as amended from time to time, read with Article 44(2) of the Constitution, I, Mahinda Rajapaksa, President, do by this Order, Vest in the People's Bank established under the People's Bank Act, No. 29 of 1961, with effect from 05th March Two Thousand Fourteen, the properties described in the Schedule hereto.

#### SCHEDULE

1. All that piece of land situated at Karaveddy Kurulikulrichy in the Parish of Kaddaveli Kovilpattu in the Division of Vadamarachchi Jaffna District Northern Province called "Palaniyawattai" in extent 22 1/4 lachams, V.C. on the Northern side of the said extent of 22 1/4 lachams an extent of 7 1/4 lachams V.C. from and out of this on the Northern side an extent of 3 5/8 lachams V.C. (A.0, R. 0, P. 33.75) bounded on the East : by the property of Kanthavanam Murugesu and others and North : by the property of Sellachi (widow of Ponnaiah) and others, West : by the property of Sinnathangam wife of Navasivayam and others, South : by the property of Sihhathamby Mailvaganam and others together with share of well standing on the Western land called Manthiyollai and the right of use of the way and water course.

This land is registered in Folio A 441/148 in the Land Registry, Point Pedro.

2. All that divided and defined allotment of land marked as the remaining portion of Lot No. 1A of the land called "Maragahawatta and Gorakagahawatta, situated at Battaramulla Road, Pannipitiya in the Village of Depanama in Maharagama Urban Council Division within the Pradeshiya Sabha limits of Maharagama in Palle Pattu, Salpiti Korale in the District of



Colombo Western Province and bounded on the North by : land belongs to K. William Perera, on the East by : Road leads to Pannipitiya from Battaramulla, on the South by : Lot No. A2 (Road reservation of 5 feet wide) and on the West by : previously sold land containing in extent seven perches and containing in extent Seven Perches and Eighty Eight on Hundredth (A.0, R.0, P. 7 88/100) together with trees, plantations, house and everything else standing thereon.

All that one half share out of undivided one half share (1/2 out of 1/2) out of the land situated at Bulathsinhala in Gangabada Pattu of Pasdum Korale East in the District of Kalutara Western Province called "Widanalage Watte Pita Kattiya" containing in extent One Acre, Three Roods, and Twenty Five Perches (A.1, R. 3, P. 25) which is bounded on the North by : Land claimed by the natives, on the East by : Land depicted in Plan No. 313842 and the Lot No. 6648 depicted in Preliminary Plan No. 15842, on the South by : Crown land and on the West by : Land Depicted in Plan No. 280762 together with trees, plantations and everything else standing thereon.
